RESOLUTION NO. 146-2023

DECLARING THE SUPPLEMENTAL BUDGET NO. 5 FOR CALENDAR YEAR 2022 OF BURGOS, PANGASINAN INVOLVING A TOTAL APPROPRIATIONS OF P3,487,400.00, OPERATIVE IN ITS ENTIRETY

WHEREAS, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

WHEREAS, the Sangguniang Bayan of Burgos, Pangasinan submitted its Supplemental Budget No. 5 for Calendar Year 2022 involving total appropriations of P3,487,400.00, which was enacted on December 22, 2022 through Appropriation Ordinance No. 06-2022;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted review and study on said budget with the following findings:

1. That the grant of Other Personnel Benefits Service Recognition Incentive (SRI) to regular & casual employees for FY 2022 shall be subject to the provisions of Administrative Order No. 1 dated December 16, 2022 by the Office of the President; and

> That the funding sources for the subject supplemental budget were determined in accordance with the provisions of Section 321 of R.A. 7160 and Article 417 (a) of its IRR as amended by Administrative Order No. 47 dated April 12, 1993.

WHEREAS, the Sangguniang Panlalawigan after final evaluation, finds the same in order provided that the findings shall be complied with by the municipality;

WHEREFORE, in view of the foregoing, on motion of SP Members Napoleon C. Fontelera, Jr. and Apolonia DG. Bacay and co-sponsored by SP Members Jerome Vic O. Espino, Jeanne Jinky C. Zaplan and Arthur C. Celeste, Jr., duly seconded, it was—
