**RESOLUTION NO. 158-2023**

**DECLARING ORDINANCE NO. 8-2022 OF THE SANGGUNIANG BAYAN OF URBIZTONDO, PANGASINAN, ENTITLED “AN ORDINANCE COVERING THE RULES AND REGULATIONS IN THE OPERATION OF THE PUBLIC MARKET IN THE MUNICIPALITY OF URBIZTONDO TO BE KNOWN AS “MARKET CODE OF URBIZTONDO, PANGASINAN”, AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT**

**WHEREAS**, the Sangguniang Bayan of Urbiztondo, Pangasinan submitted its Ordinance No. 8-2022 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer of the Province and the Acting Provincial Treasurer have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Sections 129, 132 and 447 (a) (2) (3) (i) (iii) (5) (ii) of R.A. No. 7160;

**WHEREAS**, subject ordinance shall take effect after the Sangguniang Bayan has complied with the requirement of publication pursuant to Sections 511 (a) and 188 of RA 7160;

**WHEREFORE**, in view of the foregoing, on motion of SP Members Philip Theodore E. Cruz and Haidee S. Pacheco and co-sponsored by SP Members Jerome Vic O. Espino, Jeanne Jinky C. Zaplan and Arthur C. Celeste, Jr., duly seconded, it was—


