RESOLUTION NO. 164-2023

DECLARING ORDINANCE NO. 09, S-2022 OF THE SANGGUNIANG BAYAN OF CALASIAO, PANGASINAN, ENTITLED "ORDINANCE ABOLISHING THE VACANT/UNFILLED PERMANENT POSITION OF SLAUGHTERHOUSE MASTER III AT THE OFFICE OF THE MUNICIPAL AGRICULTURE OF THE MUNICIPALITY OF CALASIAO, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT


