## **RESOLUTION NO. 165-2023**

APPROVING RESOLUTION NO. 138-2022 OF THE SANGGUNIANG BAYAN OF MALASIQUI, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM NO. 005-2022 OF THE MUNICIPALITY OF MALASIQUI, PANGASINAN IN THE AMOUNT OF SIX MILLION AND FORTY THOUSAND (P6,040,000.00) PESOS"

WHEREAS, the Sangguniang Bayan of Malasiqui, Pangasinan submitted its SB Resolution No. 138-2022 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

- The Municipal Development Council Executive Committee of Malasiqui, Pangasinan prepared the Supplemental Annual Investment Program (SAIP) No. 5 CY 2022 of the LGU. This was endorsed by the Council, through MDC Resolution No. 08-2022, Series of 2022 dated December 21, 2022, to the Sangguniang Bayan for approval;
- Said Supplemental AIP, which has a total investment requirement of P6,040,000.00, covers the augmentation of funds for Personal Services (granting of Service Recognition Incentives (SRI) for municipal officials and employees) of the LGU; and

3. Funding for the Supplemental AIP is embodied in the LGU's Supplemental Budget No. 005-2022, FY 2022, which was enacted by the Sangguniang Bayan through Appropriation Ordinance No. 006-2022, dated December 22, 2022.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Malasiqui, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Shiela Marie F. Baniqued and Vici M. Ventanilla and co-sponsored by SP Members Jerome Vic O. Espino, Jeanne Jinky C. Zaplan and Arthur C. Celeste, Jr., duly seconded, it was-
