RESOLUTION NO. 166-2023

**DECLARING THE SUPPLEMENTAL BUDGET NO. 005 FOR
CALENDAR YEAR 2022 OF MALASIQUI, PANGASINAN
INVOLVING A TOTAL APPROPRIATIONS OF P6,040,000.00,
OPERATIVE IN ITS ENTIRETY**

WHEREAS, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

WHEREAS, the Sangguniang Bayan of Malasiqui, Pangasinan submitted its Supplemental Budget No. 005 for Calendar Year 2022 involving total appropriations of P6,040,000.00, which was enacted on December 22, 2022 through Appropriation Ordinance No. 006-2022;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted review and study on said budget with the following findings:

1. That the reversion of savings from Personal Services shall be in accordance with the provisions of Section 336 of RA 7160 (Use of Appropriated Funds and Savings); and
2. That the grant of Service Recognition Incentive (SRI) to regular & casual employees for FY 2022 shall be subject to the provisions of Administrative Order No. 1 dated December 16, 2022 by the Office of the President.
