## **RESOLUTION NO. 167-2023**

APPROVING RESOLUTION NO. 162-A-2022 OF THE SANGGUNIANG BAYAN OF MANAOAG, PANGASINAN, ENTITLED "APPROVING THE 3<sup>RD</sup> SUPPLEMENTAL INVESTMENT PROGRAM FOR CALENDAR YEAR 2022 OF THE MUNICIPALITY OF MANAOAG, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Manaoag, Pangasinan submitted its SB Resolution No. 162-A-122 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

- 1. The Municipal Development Council of Manaoag, Pangasinan prepared the municipality's 3rd Supplemental Investment Program for CY 2022. This was endorsed by the Council, through MDC Resolution No.04, Series of 2022 dated September 20, 2022, to the Sangguniang Bayan for approval;
- 2. Said Supplemental Investment Program (SIP), which has a total investment requirement of ₱3,518,416.29, covers augmentation funds for Personal Services (granting of Service Recognition Incentives for municipal officials and employees) and Maintenance & Other Operating Expenses of the LGU; and

> 3. Funding for the SIP is embodied in the LGU's Supplemental Budget No. 3, FY 2022, which was enacted by their Sangguniang Bayan through Appropriation Ordinance No. 03, Series of 2022 dated December 19, 2022.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Manaoag, Pangasinan;
