**APPROVING RESOLUTION NO. 330, S-2022 OF THE SANGGUNANG BAYAN OF BAUTISTA, PANGASINAN, ENTITLED "ADOPTING THE FORMULATED ANNUAL INVESTMENT PROGRAM OF MUNICIPALITY OF BAUTISTA, PANGASINAN FOR CALENDAR YEAR 2023 UNDER MUNICIPAL DEVELOPMENT COUNCIL RESOLUTION NO. 2, SERIES OF 2022 AMOUNTING TO ONE HUNDRED THIRTY-NINE MILLION NINE HUNDRED EIGHTY-FOUR THOUSAND SIX HUNDRED THIRTY-NINE PESOS (P139,984,639.00)"**

**WHEREAS**, the Sangguniang Bayan of Bautista, Pangasinan submitted its SB Resolution No. 330, S-2022 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

1. The Local Development Council of Bautista, Pangasinan has formulated the municipality's Annual Investment Program for Calendar Year 2023, which was endorsed to the Sangguniang Bayan for approval through MDC Resolution No. 02 S. of 2022 dated September 13, 2022. This was subsequently approved by the Sangguniang Bayan through Resolution No. 330 s. of 2022 dated December 12, 2022. This is in pursuance to Sections 106, 109, and 114 of the Local Government Code of 1991;

2. The AIP of the municipality is in accordance with the Budget Operations Manual (BOM) for LGUs, 2016 Edition and in pursuance to DILG-NEDA-DBM-DOF Joint Memorandum Circular No. 1 series of 2007 dated March 8, 2007 DBM-CCC-DILG JMC No. 2014-01 dated August 7, 2014, as amended by DBM-CCC-DILG JMC No. 2015-01 dated July 23, 2015 as to format and content. The AIP of Bautista, Pangasinan was formulated following the prescribed AIP Summary Form categorized into general public, social, economic, and other services. It likewise covers: (a) all the regular budgetary items for the operations of the different offices broken down into PS, MOOE, and Capital Outlay; (b) the priority development programs/projects and those to be funded by the 20% development fund, and; (c) disaster risk reduction management programs/projects/activities of the municipality. It further includes the following: 1) Gender and Development Plan w/ DILG Certification, Peace and Order Plan, Local Nutrition Plan, Tourism, Culture Preservation & Conservation Plan, Climate Change Action Plan, Local Youth Development Plan, Annual Procurement Plan, and; 2) list of programs/projects/activities for the Local Council for Protection of Children, Senior Citizens and Persons with Disabilities, PPAs to combat Acquired Immune Deficiency Syndrome, and to address Problems on Illegal Drugs;
3. The AIP has a total investment requirement amounting to Php 139,984,639.00 which will be funded from the municipality's proposed 2023 Annual Budget, enacted on December 12, 2022 through Appropriation Ordinance No.3, Series of 2022;
4. The development fund amounting to Php 26,854,810.20, which is allocated for development projects is equivalent to the 20% of the municipality's NTA amounting to Php134,274,051.00 for CY 2023. This is in accordance with Section 287 of RA 7160;

The identified development programs/projects to be funded by the 20% of IRA are based on the DILG-DOF-DBM Joint Memorandum Circular No. 1 dated November 4, 2020 (Revised Guidelines on the Appropriation and Utilization of the 20% of the Annual Internal Revenue Allotment for Development Projects);

5. The identified programs/projects/activities to be funded by the 5% Local Disaster Risk Reduction and Management Fund of the municipality amounting to Php 6,999,231.95, conforms with Section 21 of RA 10121. The programs/projects/activities to be funded from the 70% of the LDRRMF conform with the NDRRMC-DBM and DILG

Joint Memo Circular (JMC) No. 2013-1 dated March 25, 2013 (Allocation and Utilization of Local Disaster Risk Reduction and Management Fund). However, the 30% of the LDRRM Fund amounting to PhP2,099,769.58 shall be appropriated for Quick Response Fund (QRF) in lump sum appropriation as provided for in Section 4 of the above-mentioned JMC. The LDRRM Plan 2019-2025 of the municipality has been reviewed by the Office of Civil Defense (OCD) as per attached OCD Certification dated November 4, 2019;

6. The LGU has also identified programs/projects/activities responsive to climate change and tagged its corresponding expenditures in their AIP. This is in pursuance to DBM-CCC-DILG Joint Memorandum Circular No. 2015-01 dated July 23, 2015; and
7. The Gender and Development Plan of the municipality has been reviewed by the Department of the Interior and Local Government (DILG) and was found to be fully compliant in form and contents with the provisions of the Joint Memo Circular of 2016-01: Amendments to JMC 2013-01 re: Guidelines on Localization of the Magna Carta of Women as per attached Certificate of Review and Endorsement of the DILG dated May 26, 2022.

**WHEREAS**, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Bautista, Pangasinan;

**WHEREFORE**, in view of the foregoing, on motion of SP Members Rosary Gracia P. Perez-Tababa and Nicholi Jan Louie Q. Sison and co-sponsored by SP Members Jerome Vic O. Espino, Jeanne Jinky C. Zaplan and Arthur C. Celeste, Jr., duly seconded, it was—




