DECLARING ORDINANCE NO. 4, S-2022 OF THE SANGGUNIANG BAYAN OF BAUTISTA, PANGASINAN, ENTITLED "ORDINANCE CHANGING THE POSITION TITLE OF CIVIL REGISTRY CLERK III (PLANTILLA ITEM NO. 510-11) TO CLERK III IN THE OFFICE OF THE MUNICIPAL REGISTRAR EFFECTIVE OCTOBER 17, 2022" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Bautista, Pangasinan submitted its Ordinance No. 4, S-2022 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Sections 76 and 447 (a) (1) (viii) of R.A. No. 7160;

WHEREAS, however, the position title should be changed to Administrative Aide VI (Clerk III), Salary Grade 6 to conform with the provisions of Local Budget Circular No. 137 (Index of Occupational Services, Position Titles and Salary Grades for Local Government (IOS-LGU), Calendar Year 2021 Edition) dated July 13, 2021.
