**DECLARING ORDINANCE NO. 5, S-2022 OF THE SANGGUNIANG BAYAN OF BAUTISTA, PANGASINAN, ENTITLED "ORDINANCE CHANGING THE POSITION TITLE OF ADMINISTRATIVE AIDE III (CLERK) (PLANTILLA ITEM NO. 1-46) TO ADMINISTRATIVE AIDE II (UTILITY WORKER II) IN THE OFFICE OF THE MUNICIPAL MAYOR EFFECTIVE OCTOBER 17, 2022" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT**


