DECLARING ORDINANCE NO. 6, S-2022 OF THE SANGGUNIANG BAYAN OF BAUTISTA, PANGASINAN, ENTITLED "ORDINANCE CHANGING THE POSITION TITLE OF REVENUE COLLECTION CLERK I (PLANTILLA ITEM NO. 1122-27) SG 5 AT THE MUNICIPAL TREASURER'S OFFICE TO LOCAL YOUTH DEVELOPMENT ASSISTANT I, SG 5 AND BE TRANSFERRED AT THE MUNICIPAL SOCIAL WELFARE AND **DEVELOPMENT OFFICE EFFECTIVE NOVEMBER 7, 2022" AS** WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN **TO ENACT**
