RESOLUTION NO. 178-2023

DECLARING MUNICIPAL ORDINANCE NO. 2023-001 OF THE SANGGUNIANG BAYAN OF TAYUG, PANGASINAN, ENTITLED "AN ORDINANCE AMENDING SECTION 3 AND SECTION 5 OF MUNICIPAL ORDINANCE NO. 2022-015, ENTITLED "AN ORDINANCE CREATING POSITIONS IN THE MUNICIPAL GOVERNMENT OF TAYUG, PANGASINAN, DEFINING THE DUTIES, FUNCTIONS, AND QUALIFICATIONS AND PROVIDING FUNDS THEREOF" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG TO ENACT

WHEREAS, the Sangguniang Bayan of Tayug, Pangasinan submitted its Ordinance No. 2023-001 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;


