RESOLUTION NO. 179-2023

DECLARING MUNICIPAL ORDINANCE NO. 2023-002 OF THE SANGGUNIANG BAYAN OF TAYUG, PANGASINAN, ENTITLED "AN ORDINANCE EXTENDING THE DEADLINE FOR THE ASSESSMENT AND PAYMENT OF BUSINESS PERMIT AND TRICYCLE PERMIT IN THE MUNICIPALITY OF TAYUG, PANGASINAN FROM JANUARY 21, 2023 TO JANUARY 31, 2023 WITHOUT PENALTIES, SURCHARGES AND INTERESTS" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Tayug, Pangasinan submitted its Ordinance No. 2023-002 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer of the Province have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Sections 16, 167 & 192 and Article 282 of the Implementing Rules and Regulations of R.A. No. 7160;

WHEREAS, subject ordinance shall take effect after the Sangguniang Bayan of Tayug, Pangasinan has complied with the requirement of posting pursuant to Section 59 (a) of RA No. 7160;
