### RESOLUTION NO. 18-2023

**APPROVING RESOLUTION NO. 73, S-2022 OF THE SANGGUNIANG BAYAN OF BASISTA, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM (SIP) NO. 2 FOR CY 2022 OF BASISTA, PANGASINAN"**

**WHEREAS**, the Sangguniang Bayan of Basista, Pangasinan submitted its SB Resolution No. 73, S-2022 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

1. The Municipal Development Council of Basista, Pangasinan prepared their Supplemental Investment Program (SIP) No. 2 for CY 2022. This was endorsed by the Council, through MDC Resolution No. 3, Series of 2022 dated November 9, 2022, to the Sangguniang Bayan for approval;
2. Said Supplemental Annual Investment Program, which has a total investment requirement of ₱6,749,289.59, covers augmentation of funds for Personal Services (granting of Performance Based Bonus to qualified personnel of the LGU), Maintenance and Other Operating Expenses (MOOE) and Capital Outlay (CO) of some municipal office of the LGU, and implementation of LDRRM projects/activities of LGU Basista; and

3. Funding for the Supplemental AIP is embodied in the LGU's Supplemental Budget No. 2, FY 2022, which was enacted by their Sangguniang Bayan through Appropriation Ordinance No. 3, Series of 2022 dated November 14, 2022.

**WHEREAS**, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Basista, Pangasinan;
