DECLARING MUNICIPAL ORDINANCE NO. 2022-013 OF THE SANGGUNIANG BAYAN OF TAYUG, PANGASINAN, ENTITLED "AN ORDINANCE CENTRALIZING THE COLLECTION OF CORRESPONDING BARANGAY CLEARANCE FEE IN THE APPLICATION FOR ANY BUSINESS-RELATED TRANSACTIONS" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Tayug, Pangasinan submitted its Ordinance No. 2022-013 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer of the Province have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Section 447 (3) (i) of R.A. No. 7160 and Section 11 (f) of R.A. No. 11032;

WHEREAS, subject ordinance shall take effect after the Sangguniang Bayan has complied with the requirements of Sections 59 (a), 187 and 188 of RA No. 7160;
