RESOLUTION NO. 182-2023

DECLARING THE ANNUAL BUDGET FOR CALENDAR YEAR 2023 OF UMINGAN, PANGASINAN INVOLVING A TOTAL APPROPRIATIONS OF Php296,223,734.00 UNDER GENERAL FUND AND OPERATION OF ECONOMIC ENTERPRISE, OPERATIVE IN ITS ENTIRETY

WHEREAS, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

WHEREAS, the Sangguniang Bayan of Umingan, Pangasinan submitted its Annual Budget for Calendar Year 2023 involving total appropriations of Php296,223,734.00, which was enacted on November 16, 2022 through Appropriation Ordinance No. 3, S-2022;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted review and study on said budget with the following findings:

1. That all programs, projects and activities shall be in accordance with the approved Local Development Plan and the 2023 Annual Investment Program of the municipality formulated pursuant to DILG-NEDA-DBM-DOF Joint Memo Circular No. 1, series of 2007 dated March 8, 2007;

2. That the projects funded under the 20% of the Annual National Tax Allotment for development projects (20% Development Fund) shall be subject to the provisions of DBM-DOF-DILG Joint Memorandum Circular (JMC) No. 1 dated November 4, 2020 Re: Revised Guidelines on the Appropriation and Utilization of the Twenty Percent (20%) of the Annual Internal Revenue Allotment (IRA) for the Development Projects;
3. That the items funded out of the Local Disaster Risk Reduction & Management Fund shall be in accordance with R.A No. 10121 known as the Philippine Disaster Risk Reduction & Management Act of 2010 and its IRR, and the DBM-NDRRM-DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013 re: Allocation & Utilization of the Local Disaster Risk Reduction & Management Fund (LDRRMF) & that 30% shall be set aside as Quick Response Fund;
4. That all procurements to be undertaken shall be subject to the pertinent provision of R.A No. 9184 (The Government Procurement Reform Act) and its Revised Implementing Rules and Regulations;
5. That the grant of Step Increment to some municipal employees shall be in accordance with the CSC-DBM Joint Circular No. 1, series of 2012 dated September 3, 2012 & CSC-DBM Joint Circular No.1, s-2016 dated January 27, 2016;
6. That the position title and salary grade allocation of the following should be adjusted to conform with Local Budget Circular No. 137 (Index of Occupational Services, Position Titles and Salary Grades in the Local Government (IOS-LGU), CY 2021 Edition, dated July 13, 2021;

7. That the Ordinance enumerating the qualifications, duties & functions of the newly-created positions should be submitted; and
8. That the appropriation for devolved functions and services in FY 2023 shall be in accordance with the provisions of Executive Order No. 138 dated June 1, 2021 and DILG-DBM Joint Memorandum Circular No. 2021-1 dated August 11, 2021 and shall be consistent with the Devolution Transition Plan of the municipality and further subject to the provisions of LBC No. 145 dated March 2, 2022.


