PROVINCIAL RESOLUTION NO. 189-2023

**APPROVING THE ESTABLISHMENT OF THE PANGASINAN
SAFETY AND EMERGENCY RESPONSE, COMMAND,
CONTROL AND COMMUNICATIONS (PASER C3) CENTER AS
THE PROVINCE OF PANGASINAN'S EMERGENCY 911
HOTLINE CENTER**

WHEREAS, the Sangguniang Panlalawigan is in receipt of PDRRMC Resolution No. 1, S-2023 entitled "Supporting and Adopting the Institutionalization of Pangasinan Safety and Emergency Response, Command, Control and Communications (PASER C3) Center" as the Province of Pangasinan's Emergency 911 Hotline Center;

WHEREAS, the Provincial Disaster Risk Reduction and Management Council (PDRRMC) through the Provincial Disaster Risk Reduction and Management Office (PDRRMO) has designed to establish a Pangasinan Safety and Emergency Response (PASER) Command Center in the Province to ensure public safety and security, maintain public order and respond promptly to emergency situations in the entire Province;

WHEREAS, the establishment of PASER C3 in the Province of Pangasinan is in pursuance to RA 10121 or the Philippine Disaster Risk Reduction Management Act of 2010 which paved the way for the adoption of a disaster risk reduction and management approach that is holistic, comprehensive, integrated and proactive in lessening the socio-economic and environmental impacts of disasters including climate change and which promote involvement and participation;

WHEREAS, likewise, the establishment of PASER C3 in the Province of Pangasinan is anchored on Executive Order No. 56, S-2018 which institutionalized the use of the number 911 as the Nationwide Emergency Hotline Number to be known as the Emergency 911 Hotline and for which local government units are enjoined to establish and run a local 911 call centers within their area of jurisdiction;

WHEREAS, the establishment of PASER C3 is beneficial to the populace of Pangasinan as it will serve as a frontline service area for over-all emergency operations and network communication in the entire Province;

WHEREAS, with the establishment of the PASER C3, the Provincial Government of Pangasinan will have direct links with response units from local as well as national agencies like the Bureau of Fire Protection Provincial Office, Pangasinan Police Provincial Office and the Philippine Coast Guard in order to enhance disaster risk preparedness and response capabilities to ensure a more safe and secure province;

WHEREAS, the establishment of PASER C3 is to set up the cooperation and coordination approach between and among concerned government agencies in order to sustain the momentum of service to the public;


WHEREAS, the Sangguniang Panlalawigan fully supports the establishment of the PASER C3 in the Province of Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Member Vici M. Ventanilla and co-authored by all Members of the Sangguniang Panlalawigan, duly seconded, it was –


