#### PROVINCIAL RESOLUTION NO. 189-2025

REQUESTING THE OFFICE OF THE PROVINCIAL GOVERNOR TO INSTRUCT THE PANGASINAN POLYTECHNIC COLLEGE **EDUCATION SKILLS** AND **TECHNICAL** AND THE DEVELOPMENT AUTHORITY (TESDA) - PROVINCIAL OFFICE TO STUDY THE POSSIBILITY OF OFFERING FREE BASIC **TRAINING** HEALTH **SERVICE** BARANGAY ACCREDITATION FOR BARANGAY HEALTH WORKERS IN THE PROVINCE OF PANGASINAN

**WHEREAS,** Barangay Health Workers (BHWs) are active partners of the local government units in the promotion and implementation of the basic health programs, projects and activities, particularly in the barangays;

WHEREAS, the Sangguniang Panlalawigan, during its inquiry held on January 20, 2025 Regular Session, has learned that BHWs are required to undergo NC-II training course that entails them to pay a promulgated assessment fee of P970.00, as stipulated in the TESDA Circular No. 072, Series of 2021;

WHEREAS, the Sangguniang Panlalawigan acknowledges that Barangay Health Workers are practically working for very minimal financial allowances that cannot be considered enough to support their families;

WHEREAS, considering the importance of their services in their respective localities, the Sangguniang Panlalawigan recognizes the importance of conducting a study for the provision of a basic barangay health service training and accreditation for barangay health workers to enhance their capacities to achieve the full realization of primary care, and as an important strategy to ensure quality, safe and affordable care;

WHEREAS, this basic barangay health service training is essential to BHWs as this will upgrade their technical and institutional capacities;

WHEREAS, the Sangguniang Panlalawigan further recognizes that the Pangasinan Polytechnic College and the Technical Education and Skills Development Authority (TESDA) – Provincial Office play a critical role in exploring ways to provide BHWs access to free training courses;

WHEREAS, for the above purposes, the Sangguniang Panlalawigan is hereby requesting the Office of the Governor to instruct the aforesaid institutions for the formulation of basic health care trainings and programs for barangay health workers in the Province of Pangasinan;
