PROVINCIAL RESOLUTION NO. 190-2025

APPROVING THE FIVE-YEAR INSTITUTIONAL DEVELOPMENT PLAN (IDP) OF THE PANGASINAN POLYTECHNIC COLLEGE (PPC)

WHEREAS, Provincial Ordinance No. 314-2024, An Ordinance Amending Provincial Ordinance No. 300-2023, both enacted by the Sangguniang Panlalawigan of Pangasinan, empowers the Governing Board of the PPC to establish effective and efficient structure of the Pangasinan Polytechnic College (PPC) and to approve plans or policies related to the overall governance of PPC;

WHEREAS, an Interim Governing Board of the PPC was constituted by virtue of Executive Order No. 0004, Series of 2024, which shall carry out the powers and duties stipulated in Provincial Ordinance No. 300-2024, as amended by Provincial Ordinance No. 314-2024;

WHEREAS, presented for consideration by the Sangguniang Panlalawigan is the Five-Year Institutional Development Plan (IDP) of the Pangasinan Polytechnic for Calendar Years 2025-2029 as approved and endorsed by the PPC Interim Governing Board;

WHEREAS, the Institutional Development Plan of the PPC is a vital strategy of the College which outlines its strategic goals, objectives, and actions to guide its development and growth;

WHEREAS, the IDP was likewise assembled by the PPC in preparation for its application for Certificates of Program Compliance (COPC) for its four baccalaureate programs, and eventually, for Institutional Recognition (IR) from the Commission on Higher Education;
