RESOLUTION NO. 191-2023

DECLARING THE SUPPLEMENTAL BUDGET NO. 3 FOR CALENDAR YEAR 2022 OF THE CITY OF ALAMINOS, PANGASINAN INVOLVING A TOTAL APPROPRIATIONS OF P21,459,862.41, OPERATIVE IN ITS ENTIRETY

WHEREAS, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

WHEREAS, the Sangguniang Panlungsod of Alaminos, Pangasinan submitted its Supplemental Budget No. 3 for Calendar Year 2022 involving total appropriations of P21,459,862.41 which was enacted on November 29, 2022 through Appropriation Ordinance No. 2022-03;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted review and study on said budget with the following findings:

1. That the funding sources for the subject supplemental budget were determined in accordance to Section 321 of R.A. 7160 and Article 417 (a) of its IRR as amended by Administrative Order No. 47 dated April 12, 1993;
2. That all procurements to be undertaken shall be subject to the pertinent provisions of R.A. 9184 (The Government Procurement Reform Act) and its Implementing Rules and Regulations;

3. That the grant of Service Recognition Incentive (SRI) to regular & casual employees for FY 2022 shall be subject to the provisions of Budget Circular No. 2022-4 dated December 20, 2022; and
4. That all programs, projects and activities shall be in accordance with the approved LDP and the Fiscal Year 2022 Supplemental Investment Program of the city formulated pursuant to DILG-NEDA-DBM-DOF Joint Memorandum Circular No. 1, Series of 2007 dated 08 March 2007.


WHEREAS, the Sangguniang Panlalawigan after final evaluation, finds the same in order provided that the findings shall be complied with by the City;
