### PROVINCIAL RESOLUTION NO. 191-2025

**AUTHORIZING THE HONORABLE GOVERNOR, RAMON V. GUICO III, TO PURCHASE VEHICLE-SIX (6) UNITS OF AMBULANCE FOR USE BY THE PROVINCIAL GOVERNMENT OF PANGASINAN**

**WHEREAS**, the Provincial Government of Pangasinan is in need of ambulances which shall be used to by the Provincial Governor’s Office/Provincial Hospital Management Services Office as a means to transport the sick and/or injured patients to, from and between places of treatment, affording safety and comfort to the patients to avoid aggravation of illness or injury;

**WHEREAS**, the Provincial Government of Pangasinan intends to purchase six (6) units of ambulance with a total fund source of P15,000,000.00 coming from the FY 2023 LGSF-Other Financial Assistance (FA) Program which have been transferred from the General Fund to the Provincial Government Trust Fund Account;

**WHEREAS**, the six (6) units of ambulance have the following specifications:

**WHEREAS**, the Provincial Government of Pangasinan shall comply with DILG Memorandum Circular No. 2014-155 dated December 17, 2014 which provides the “Guidelines on Motor Vehicles Acquisition by the Local Government Units” and DBM Budget Circular No. 2016-5 dated August 22, 2016 which “Revised the Guidelines on the Acquisition and Use of Government Motor Vehicles” in the procurement of the said vehicle;
