RESOLUTION NO. 192-2023

APPROVING RESOLUTION NO. 97, S-2022 OF THE SANGGUNANG BAYAN OF DASOL, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM NO. 04, CY 2022 OF THE LOCAL GOVERNMENT UNIT, DASOL, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Dasol, Pangasinan submitted its SB Resolution No. 97, S-2022 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

1. Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Local Development Council of Dasol, Pangasinan has identified items in their Supplemental Annual Investment Program (SAIP) No.4 CY 2022. This was endorsed to the Sangguniang Bayan on December 2, 2022 through MDC Resolution No. 5, Series of 2022;
2. Said SAIP No. 4 covers fund augmentation for Personal Services (granting of Performance-Base Bonus and Service Recognition Incentive to qualified LGU officials and employees, and other personnel benefits), MOOE and Capital Outlay of various municipal government offices, and the implementation of disaster risk reduction management program and other priority development programs/projects of the local government unit; and

3. Funding support for the proposed SAIP, with a total investment requirement of Php14,790,047.09, is embodied in the municipality's Supplemental Budget No.4 CY 2022, which was approved and enacted by their Sangguniang Bayan through Appropriation Ordinance No.179 on December 12, 2022 and approved by the Municipal Mayor on December 27, 2022


