RESOLUTION NO. 196-2025

APPROVING MUNICIPAL RESOLUTION NO. 198-2024 OF THE SANGGUNIANG BAYAN OF ANDA, PANGASINAN, ENTITLED "APPROVING THE ANNUAL INVESTMENT PROGRAM (AIP) OF THE MUNICIPALITY OF ANDA, PANGASINAN FOR CY 2025 AND AUTHORIZED ITS IMPLEMENTATION EFFECTIVE JANUARY 1, 2025"

WHEREAS, the Sangguniang Bayan of Anda, Pangasinan submitted its Resolution No. 198-2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

- In pursuance to Sections 106, 109, and 114 of the Local Government Code of 1991, the Local Development Council of Anda, Pangasinan has formulated the municipality's Annual Investment Program for Calendar Year 2025, which was endorsed to the Sangguniang Bayan for approval through MDC Resolution No. 06, Series of 2024 dated October 3, 2024;
- 2. The AIP of the municipality is in accordance with the Budget Operations Manual (BOM) for LGUs, 2023 Edition and in pursuance to DILG-NEDA-DBM-DOF Joint Memorandum Circular No. 1, Series of 2007 dated March 8, 2007 DBM-CCC-DILG JMC No. 2014-01 dated August 7, 2014, as amended by DBM-CCC-DILG JMC No. 2015-01 dated July 23, 2015 as to format and content. The AIP of Anda, Pangasinan was formulated following the prescribed AIP Summary Form categorized into

general public, social, economic, and other services. It likewise covers: (a) all the regular budgetary items for the operations of the different municipal offices broken down into PS, MOOE, Financial Expenses, and Capital Outlay; (b) the priority development programs/projects and those to be funded by the 20% development fund, and; (c) disaster risk reduction management programs/projects/activities of the municipality. It also includes the following: 1) Gender and Development Plan, Peace and Order Plan, Nutrition Plan, Tourism Plan, Cultural Development Plan, Local Climate Change Action Plan, Annual Procurement Plan, and; 2) list of programs/projects/activities for the Local Council for Protection of Children, Senior Citizens and Persons with Disabilities, PPAs to combat Acquired Immune Deficiency Syndrome, and PPAs to Address Problems on Illegal Drugs;

- 3. The proposed AIP has a total investment requirement of Php225,312,083.65. The amount of Php222,000,000.00 will be funded from the municipality's proposed 2025 Annual Budget enacted through Appropriation Ordinance No. 05, Series of 2024 on November 21, 2024 and approved by the Municipal Mayor on December 02, 2024. The remaining programs/projects/activities will be funded under Special Trust Fund amounting to Php3,312,083.65;
- 4. The development fund amounting to Php 38,924,261.80 which is allocated for development projects is equivalent to 20% of the municipality's NTA amounting to Php194,621,309.00 for CY 2025. This is in accordance with Section 287 of RA 7160. However, the identified development programs/projects to be funded by the 20% of NTA shall be based on the DILG-DOF-DBM Joint Memorandum Circular No. 1 dated November 4, 2020 (Revised Guidelines on the Appropriation and Utilization of the 20% of the Annual Internal Revenue Allotment for Development Projects);
- 5. The Disaster Risk Reduction and Management programs, projects and activities in preparation for and to mitigate the impact of disasters to be funded by the 5% Local Disaster Risk Reduction and Management Fund of the municipality amounting to Php11,322,000.00 is integrated in the AIP and conforms with Section 21 of RA 10121. The programs/projects/ activities to be funded by the 70% of the LDRRM Fund in the amount of PhP7,925,400.00 are based on NDRRMC-DBM and DILG Memo Circular No. 2013-1 dated March 25, 2013 (Allocation and Utilization of Local Disaster Risk Reduction and Management Fund) and the 30% amounting to PhP3,396,600.00 is allocated for Quick Response Fund. Further, the LDRRM Plan 2023-2028 of the municipality has been reviewed by the Office of Civil Defense (OCD) as per attached OCD Certification dated June 28, 2022;

- The LGU has also identified programs/projects/activities responsive to climate change and tagged its corresponding expenditures in their AIP. This is in pursuance to DBM-CCC-DILG Joint Memorandum Circular No. 2015-01 dated July 23, 2015;
- 7. The Gender and Development Plan of the municipality has been reviewed by the Department of the Interior and Local Government (DILG) and was found to be fully compliant in form and contents with the provisions of the Joint Memo Circular of 2016-01: Amendments to JMC 2013-01 re: Guidelines on Localization of the Magna Carta of Women as per attached Certificate of Review and Endorsement of the DILG dated March 27, 2024; and
- 8. Included in the AIP are programs/projects to be funded by external sources.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Anda, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Napoleon C. Fontelera, Jr. and Apolonia DG. Bacay and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to approve Municipal Resolution No. 198-2024 of the Sangguniang Bayan of Anda, Pangasinan, entitled "Approving the Annual Investment Program (AIP) of the Municipality of Anda, Pangasinan for CY 2025 and authorized its implementation effective January 1, 2025";
