AUTHORIZING THE PROVINCIAL GOVERNOR, RAMON V. GUICO III, TO ENTER INTO AND SIGN A DEED OF DONATION AND RECEIVE VARIOUS EQUIPMENT FROM THE DEPARTMENT OF HEALTH – CENTER FOR HEALTH DEVELOPMENT I FOR THE DASOL COMMUNITY HOSPITAL

WHEREAS, the Department of Health (DOH) is the principal agency of the government which consistently contributes to the upgrading of medical and health care facilities and has manifested its desire to further augment its support to the Provincial Government of Pangasinan’s health care program through the Health Facilities Enhancement Program (HFEP);


