### RESOLUTION NO. 202-2025

**APPROVING RESOLUTION NO. 59, S-2024 OF THE SANGGUNIANG BAYAN OF BUGALLON, PANGASINAN, ENTITLED “APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM NO. 3 FOR FY 2024 OF THE MUNICIPALITY OF BUGALLON, PROVINCE OF PANGASINAN, INVOLVING THE AMOUNT OF SEVENTEEN MILLION SEVEN HUNDRED THIRTY EIGHT THOUSAND FIVE HUNDRED FORTY SIX PESOS AND FORTY FIVE CENTAVOS (P17,738,546.45)”**

**WHEREAS**, the Sangguniang Bayan of Bugallon, Pangasinan submitted its Resolution No. 59, S-2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

1. The Municipal Development Council of Bugallon, Pangasinan prepared their Supplemental Investment Program (SIP) No. 3 for FY 2024. This was endorsed by the Council, through MDC Resolution No. 04, Series of 2024 dated December 12, 2024, to the Sangguniang Bayan for approval. This is in accordance with Sections 106, 109 and 114 of the Local Government Code of 1991;
2. Said Supplemental Investment Program, which has a total investment requirement of ₱17,738,546.45, covers the augmentation of funds for Personal Services (granting of Service Recognition Incentives and Collective Negotiation Agreement Incentives to qualified LGU Officials

and employees, and other personnel benefits), Maintenance and Other Operating Expenses (MOOE) and implementation of development projects, disaster risk reduction programs and gender and development program of the LGU; and

3. Funding support for the SIP is embodied in the LGU's Supplemental Budget No. 3 for FY 2024, which was enacted by their Sangguniang Bayan through Appropriation Ordinance No. 2024-03 dated December 18, 2024.

**WHEREAS**, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Bugallon, Pangasinan;

**WHEREFORE**, in view of the foregoing, on motion of SP Members Philip Theodore E. Cruz and Haidee S. Pacheco and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—

**RESOLVED**, by the Sangguniang Panlalawigan in session assembled, to approve Resolution No. 59, S-2024 of the Sangguniang Bayan of Bugallon, Pangasinan, entitled “Approving the Supplemental Investment Program No. 3 for FY 2024 of the Municipality of Bugallon, Province of Pangasinan, involving the amount of Seventeen Million Seven Hundred Thirty Eight Thousand Five Hundred Forty Six Pesos and Forty Five Centavos (P17,738,546.45)”;
