**APPROVING RESOLUTION NO. 283-12282022 OF THE SANGGUNANG BAYAN OF POZORRUBIO, PANGASINAN, ENTITLED “APPROVING THE FOURTH (4<sup>TH</sup>) SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM FOR CY 2022 TO BE FUNDED BY UNAPPROPRIATED SURPLUS AND SAVINGS OF POZORRUBIO, PANGASINAN”**

**WHEREAS**, the Sangguniang Bayan of Pozorrubio, Pangasinan submitted its Resolution No. 283-12282022 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

1. Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Local Development Council of Pozorrubio, Pangasinan has identified items in their 4<sup>th</sup> Supplemental Annual Investment Program (SAIP) for CY 2022. This was endorsed to the Sangguniang Bayan on December 21, 2022 through MDC Resolution No. 05, Series 2022;
2. The 4<sup>th</sup> SAIP of the municipality covers fund augmentation for Personal Services (granting of Service Recognition Incentive to government employees), assistance to Contract of Service and Job Order employees, and implementation of disaster risk reduction & management programs/projects/activities; and

3. The total investment requirement of the said SAIP, in the amount of Php5,563,000.00 is embodied in the municipality's Supplemental Budget No. 4 FY 2022, which was enacted by their Sangguniang Bayan through Appropriation Ordinance No. 05-12282022 on December 28, 2022.


**WHEREAS**, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Pozorrubio, Pangasinan;


