APPROVING RESOLUTION NO. 483, S-2024 OF THE SANGGUNIANG BAYAN OF BAYAMBANG, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM NO. 10, DULY INDORSED BY THE MUNICIPAL DEVELOPMENT COUNCIL (MDC) EXECOM THRU RESOLUTION NO. 05, SERIES OF 2024 AMOUNTING TO FOURTEEN MILLION ONE HUNDRED SIXTY-NINE THOUSAND SIXTY-NINE AND 90/100 PESOS (P14,169,069.90)"

WHEREAS, the Sangguniang Bayan of Bayambang, Pangasinan submitted its Resolution No. 483, S-2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

- 1. The Municipal Development Council of Bayambang, Pangasinan prepared the LGU's Supplemental Annual Investment Program No. 10 for CY 2024. This was endorsed by the Council, through MDC ExeCom Resolution No. 5, Series of 2024 dated December 23, 2024 to the Sangguniang Bayan for approval. This is in accordance with Sections 106, 109 and 114 of the Local Government Code of 1991;
- 2. The Supplemental Annual Investment Program, which has a total investment requirement of ₱14,169,069.90, covers the implementation of priority projects of the LGU; and

3. Funding support for the implementation of the Supplemental AIP is embodied in the LGU's Supplemental Budget No. 10, CY 2024, which was enacted by their Sangguniang Bayan through Appropriation Ordinance No. 12, Series of 2024 dated December 26, 2024.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Bayambang, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Shiela Marie F. Baniqued and Vici M. Ventanilla and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to approve Resolution No. 483, S-2024 of the Sangguniang Bayan of Bayambang, Pangasinan, entitled "Approving the Supplemental Annual Investment Program No. 10, duly indorsed by the Municipal Development Council (MDC) Execom thru Resolution No. 05, Series of 2024 amounting to Fourteen Million One Hundred Sixty-Nine Thousand Sixty-Nine and 90/100 Pesos (P14,169,069.90)";
