### RESOLUTION NO. 21-2023

#### **DECLARING THE ANNUAL BUDGET FOR CALENDAR YEAR 2023 OF BASISTA, PANGASINAN INVOLVING A TOTAL APPROPRIATION OF P146,801,594.76 OPERATIVE IN PART**

**WHEREAS**, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

**WHEREAS**, the Sangguniang Bayan of Basista, Pangasinan submitted its Annual Budget for Calendar Year 2023 involving total appropriations of P146,801,594.76, which was enacted on November 7, 2022 through Appropriation Ordinance No. 2, Series of 2022;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted review and study on said budget with the following findings:

1. That the appropriations for the implementation of the Fourth Tranche Compensation Adjustment shall be implemented only upon the issuance of salary schedule by the Department of Budget and Management granting the same;
2. That all programs, projects and activities shall be in accordance with the approved Local Development Plan and the 2023 Annual Investment Program of the municipality formulated pursuant to DILG-NEDA-DBM-DOF Joint Memo Circular No. 1, series of 2007 dated March 8, 2007;

3. That the projects funded under the 20% of the Annual National Tax Allotment for development projects (20% Development Fund) shall be subject to the provisions of DBM-DOF-DILG Joint Memorandum Circular (JMC) No. 1 dated November 4, 2020 Re: Revised Guidelines on the Appropriation and Utilization of the Twenty Percent (20%) of the Annual Internal Revenue Allotment (IRA) for the Development Projects;
4. That the Hazard Pay for health workers shall be subject to the provisions of R.A. No. 7305 (Magna Carta of Public Health Workers);
5. That the grant of Step Increments to some municipal employees shall be in accordance with the CSC-DBM Joint Circular No. 1, series of 2012 dated September 3, 2012 & CSC-DBM Joint Circular No. 01, s-2016 dated January 27, 2016;
6. That the parenthetical position title of Administrative Aide VI (Data Encoder I) SG-6 should be changed to Data Controller I or Data Entry Machine Operator I SG-6. Since the position of Data Encoder I is not among the positions authorized in the LGU; and
7. That the appropriation for devolved functions and services in FY 2023 shall be in accordance with the provisions of Executive Order No. 138 dated June 1, 2021 and DILG-DBM Joint Memorandum Circular No. 2021-1 dated August 11, 2021 and shall be consistent with the Devolution Transition Plan of the municipality and further subject to the provisions of LBC No. 145 dated March 2, 2022.

**WHEREAS**, the Sangguniang Panlalawigan after final evaluation, finds the same in order provided that the findings shall be complied with by the municipality;

**WHEREFORE**, in view of the foregoing, on motion of SP Members Philip Theodore E. Cruz and Haidee S. Pacheco and co-sponsored by SP Members Jerome Vic O. Espino, Jeanne Jinky C. Zaplan and Arthur C. Celeste, Jr., duly seconded, it was—

**RESOLVED**, as it is hereby resolved, by the Sangguniang Panlalawigan in session assembled, to declare Operative in Part the Annual Budget for Calendar Year 2023 of Basista, Pangasinan, except the filling-up of new positions since the municipality has exceeded the Personal Services Limitation pursuant to Section 325 (a) of R.A. No. 7160;




