DECLARING MUNICIPAL ORDINANCE NO. 2022-02 OF THE SANGGUNANG BAYAN OF BALUNGAO, PANGASINAN, ENTITLED "AN ORDINANCE AMENDING SECTION 5B.01 PARA 1(b) AND 2 (a to d) OF ARTICLE 5B, CHAPTER 5- MUNICIPAL CHARGES STIPULATED UNDER THE 2018 REVENUE CODE OF THE MUNICIPALITY OF BALUNGAO, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Balungao, Pangasinan submitted its Municipal Ordinance No. 2022-02 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;
