**APPROVING RESOLUTION NO. 2024-405 OF THE SANGGUNANG
BAYAN OF STA. BARBARA, PANGASINAN, ENTITLED
“APPROVING THE ANNUAL INVESTMENT PROGRAM (AIP) OF
THE MUNICIPALITY OF STA. BARBARA, PANGASINAN FOR
CALENDAR YEAR 2025”**

WHEREAS, the Sangguniang Bayan of Sta. Barbara, Pangasinan submitted its Resolution No. 2024-405, S-2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

1. Subject Resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code of 1991. The Municipal Development Council of Sta. Barbara, Pangasinan had identified and prioritized programs and projects in their Annual Investment Program for CY 2025. This was endorsed by the Council to the Sangguniang Bayan through MDC Resolution No. 2024-13, Series of 2024 dated September 10, 2024;
2. The Annual Investment Program of the municipality is in accordance with the Budget Operations Manual (BOM) for Local Government Units, 2023 Edition, and in pursuance to DILG-NEDA-DBM-DOF Joint Memorandum Circular No. 1, Series of 2007 dated March 8, 2007, DBM-CCC-DILG JMC No. 2014-01 dated August 7, 2014, as amended by DBM-CCC-DILG JMC No. 2015-1 dated July 23, 2015 as to format and content. The AIP of Sta. Barbara is categorized into general public, social,

economic and other services sectors, and covers (a) all the regular budgetary requirements for the operation of the different offices broken down into Personal Services (PS), Maintenance and Other Operating Expenses (MOOE), Financial Expenses (FE) and Capital Outlay, (b) priority development programs/projects of the LGU, including those funded by the 20% Development Fund, (c) Disaster-Risk Reduction (DRR) programs, projects, and activities, and (d) activities in pursuance of the objectives of Gender and Development (GAD) of the LGU as indicated in the DILG-endorsed GAD Plan and Budget. Also attached to the AIP are the following: (a) Local Climate Change Action Plan, (b) Peace and Order and Public Safety Plan, (c) Local Nutrition Action Plan (d) Annual Cultural Development Plan, (e) Indicative Annual Procurement Plan, (f) List of Programs/Projects/Activities (PPAs) for the Local Council for the Protection of Children, (g) List of PPAs for Senior Citizens and Persons with Disability, (h) List of PPAs to Combat AIDS and (j) List of PPAs to Address the Problems on Illegal Drugs of the LGU;

3. The proposed AIP of Sta. Barbara for CY 2024 has a total investment requirement of P453,211,488.00. Of this the amount of P448,211,488.00 will be financed by the LGU as embodied in their proposed Annual Budget for CY 2025 which was enacted by their Sangguniang Bayan through Appropriation Ordinance No. 2024-050, Series of 2024 dated September 23, 2024. The remaining amount of P5,000,000.00 will be sourced from the Local Government Support Fund (LGSF) of the National Government;
4. This AIP is in accordance with Section 287 of Local Government Code of 1991. Twenty percent (20%) of the LGU's IRA/NTA (P329,341,379.00), amounting to P65,868,476.00, is allocated for development projects. The development projects proposed to be funded from the 20% Development Fund were based on the Joint DBM-DOF-DILG Memorandum Circular No. 1 dated November 4, 2020 (Revised Guidelines on the Appropriation and Utilization of the 20% of the Annual Internal Revenue Allotment for Development Projects), except for the "Procurement of one (1) unit Pick-Up Vehicle for which use is administrative in nature as per Item 3.2.5.6 of said Memo-Circular (Purchase, maintenance or repair of motor vehicles used for administrative purposes shall not be allowed to be charged against the 20% Development Fund);
5. The attached Disaster Risk Reduction and Management Programs/Projects/Activities in preparation for and to mitigate the impact of disasters to be funded by the 5% Local Disaster Risk Reduction and Management Fund of the LGU amounting to P22,858,786.00 conform with Section 21 of RA 10121. The programs/projects to be funded from the 70% of the LDRRMF, in the amount of P16,001,150.20 are based on the NDRRMC-DBM and DILG Joint Memo Circular No. 2013-1 dated March 25, 2013 (Allocation and Utilization of Local Disaster Risk

Reduction and Management Fund) and the 30% amounting to P6,857,635.80 is allocated for Quick Response Fund (QRF). It is, however, recommended that the LDRRM Plan of the LGU be forwarded to the Office of Civil Defense – Regional Office I for their review/evaluation as per provisions of DBM Local Budget Memorandum No. 77 dated May 15, 2018, particularly Item 2.2.12 (...Annual Investment Program, supported by OCD-reviewed LDRRM Plan, etc.) and DBM Local Budget Memorandum No. 85 dated June 15, 2022, particularly Item 2.2.17 (...AIP, supported by LDRRM Plan as reviewed by the appropriate reviewing authority...);

6. The LGU of Sta. Barbara had also identified programs, projects and activities which are responsive to Climate Change and tagged its corresponding expenditures in their AIP. This is in pursuance to DBM-CCC-DILG Joint Memorandum Circular No. 2015-01 dated July 23, 2015; and
7. The Gender and Development Plan and Budget for CY 2025 of the LGU was reviewed and approved by the DILG Provincial Office, and found to be compliant in form and content with the provisions of the PCW-DILG-DBM-NEDA Joint Memorandum Circular (JMC) Nos. 2013-01 and 2016-01 (Guidelines on the Localization of the Magna Carta of Women).

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Sta. Barbara, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Shiela Marie F. Baniqued and Vici M. Ventanilla and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to approve Resolution No. 2024-405, S-2024 of the Sangguniang Bayan of Aguilar, Pangasinan, entitled “Approving the Annual Investment Program (AIP) of the Municipality of Sta. Barbara, Pangasinan for Calendar Year 2025”;
