RESOLUTION NO. 213-2025

DECLARING ORDINANCE NO. 2024-049 OF THE SANGGUNIANG BAYAN OF STA. BARBARA, PANGASINAN, ENTITLED “AN ORDINANCE CREATING THE COOPERATIVES DEVELOPMENT OFFICE AND SUBSEQUENTLY CREATING THE POSITION OF MUNICIPAL GOVERNMENT DEPARTMENT HEAD I (COOPERATIVES DEVELOPMENT OFFICER) - SALARY GRADE 24 IN THE MUNICIPAL GOVERNMENT OF STA. BARBARA, PANGASINAN DEFINING ITS DUTIES, FUNCTIONS AND QUALIFICATIONS AND PROVIDING FUNDS THEREOF” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Sta. Barbara, Pangasinan submitted its Ordinance No. 2024-049, Series of 2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer, Civil Service Commission, Human Resource Management and Development Office and the Local Finance Committee of the Province conducted initial review and study on said ordinance and found out that the same was enacted in accordance with Republic Act No. 11535, also known as “An Act Making the Position of a Cooperatives Development Officer Mandatory in the Municipal, City, and Provincial Levels, amending for the Purpose Republic Act No. 7160 otherwise known as the Local Government Code of 1991”; Sections 76, and 447 (a) (1) (viii) of R.A. No. 7160;


