DECLARING ORDINANCE NO. 5, S-2022 OF THE SANGGUNIANG BAYAN OF SAN FABIAN, PANGASINAN, ENTITLED "AN ORDINANCE CREATING THE POSITIONS OF AQUACULTURIST II, SG-15 UNDER THE OFFICE OF THE MUNICIPAL AGRICULTURIST, STOREKEEPER I, SG-4 UNDER THE OFFICE OF THE MUNICIPAL MAYOR, AND LOCAL LEGISLATIVE STAFF EMPLOYEE II, SG-4 UNDER THE OFFICE OF THE SANGGUNIANG BAYAN SECRETARIAT IN THE MUNICIPALITY OF SAN FABIAN, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT


