RESOLUTION NO. 215-2025

DECLARING ORDINANCE NO. 2024-054 OF THE SANGGUNIANG BAYAN OF STA. BARBARA, PANGASINAN ENTITLED "AN ORDINANCE MODIFYING THE PARENTHETICAL POSITION OF ADMINISTRATIVE AIDE VI-SALARY GRADE 6 FROM CLERK III TO UTILITY FOREMAN – SALARY GRADE 6 UNDER THE OFFICE OF THE SANGGUNIANG BAYAN, STA. BARBARA, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Sta. Barbara, Pangasinan submitted its Ordinance No. 2024-054, Series of 2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province conducted initial review and study on said ordinance and found out that the same was enacted in accordance with Sections 76 and 447 (a) (1) (viii) of R.A. No. 7160;

WHEREFORE, in view of the foregoing, on motion of SP Members Shiela Marie F. Baniqued and Vici M. Ventanilla and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—

Barbara, Pangasinan, entitled "An Ordinance modifying the parenthetical position of Administrative Aide VI-Salary Grade 6 from Clerk III to Utility Foreman – Salary Grade 6 under the Office of the Sangguniang Bayan, Sta. Barbara, Pangasinan" as within the conferred powers of the Sangguniang Bayan to enact;
