**PROVINCIAL RESOLUTION NO. 217-2023**

**INVITING THE HONORABLE GOVERNOR, RAMON V. GUICO III, TO DELIVER THE STATE OF THE PROVINCE ADDRESS BEFORE THE 11<sup>TH</sup> SANGGUNIANG PANLALAWIGAN ON ITS MARCH 27, 2023 REGULAR SESSION**

**WHEREAS**, Section 465 (iii) of RA 7160, otherwise known as the Local Government Code of 1991, mandates the governor to annually brief the sangguniang panlalawigan on the state of the province and to present the provincial government's programs and policies for the new calendar year;

**WHEREAS**, it is imperative that the 11<sup>th</sup> Sangguniang Panlalawigan be apprised of Honorable Governor Ramon V. Guico III's policies, priority development plans, and programs for the Provincial Government to engender further an atmosphere for an effective and closely coordinated working relationship between the Province's executive and legislative bodies;

**WHEREAS**, optimum coordination between the executive and legislative bodies of the Provincial Government could best be achieved by enabling the Hon. Provincial Governor to personally inform the 11<sup>th</sup> Sangguniang Panlalawigan of his defined goals and priorities;

**WHEREAS**, the 11<sup>th</sup> Sangguniang Panlalawigan would be honored to listen to the Governor's Report of Honorable Ramon V. Guico III in one of its Regular Sessions preferably on March 27, 2023, so it could be appropriately documented into the annals of history of the legislative body of the Province;

**NOW, THEREFORE**, on unanimous motion, duly seconded, it was - ;

**RESOLVED**, by the Sangguniang Panlalawigan in session assembled to invite, as he is hereby invited, the Honorable Governor, Ramon V. Guico III, to deliver the State of the Province Address before the 11<sup>th</sup> Sangguniang Panlalawigan on its March 27, 2023 Regular Session;




