RESOLUTION NO. 218-2025

DECLARING MUNICIPAL ORDINANCE NO. 2024-06 OF THE SANGGUNIANG BAYAN OF BINALONAN, PANGASINAN, ENTITLED “AN ORDINANCE APPROVING AND RATIFYING THE TERMS AND CONDITIONS OF THE APPROVED LOAN AND OTHER SUPPORTING DOCUMENTS PERTAINING TO THE LOAN ENTERED INTO BY AND BETWEEN THE MUNICIPAL GOVERNMENT OF BINALONAN REPRESENTED BY ITS MUNICIPAL MAYOR, HON. RAMON RONALD V. GUICO IV, AND THE LAND BANK OF THE PHILIPPINES REPRESENTED BY ITS ASSISTANT VICE PRESIDENT/HEAD, PANGASINAN LENDING CENTER, CESAR N. ULPINDO, IN THE AMOUNT NOT EXCEEDING THREE HUNDRED MILLION PESOS (P300,000,000.00) TO FUND THE PHASE I OF SEVEN-STOREY UNIVERSITY BUILDING OF UNIVERSITY OF EASTERN PANGASINAN INCLUDED IN THE APPROVED SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM NO. 2024-05” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Binalonan, Pangasinan submitted its Municipal Ordinance No. 2024-06 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer, Provincial Planning and Development Coordinator, and the Local Finance Committee of the Province conducted initial review and study on said ordinance and found out that the same was enacted in accordance with Sections 22 (a) (5) (c), 296 (a) (b), 297 (a) (b) (c), 444 (1) (vi), 447 (a) (2) (iii) (iv) of R.A. No. 7160;

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to declare Ordinance No. 2024-06 of the Sangguniang Bayan of Binalonan, Pangasinan, entitled “An Ordinance approving and ratifying the terms and conditions of the approved loan and other supporting documents pertaining to the loan entered into by and between the Municipal Government of Binalonan represented by its Municipal Mayor, Hon. Ramon Ronald V. Guico IV, and the Land Bank of the Philippines represented by its Assistant Vice President/Head, Pangasinan Lending Center, Cesar N. Ulpindo, in the amount not exceeding Three Hundred Million Pesos (P300,000,000.00) to fund the Phase I of Seven-Storey University Building of University of Eastern Pangasinan included in the approved Supplemental Annual Investment Program No. 2024-05” as within the conferred powers of the Sangguniang Bayan to enact;
