**APPROVING RESOLUTION NO. 2024-122 OF THE SANGGUNIANG BAYAN OF BINALONAN, PANGASINAN, ENTITLED “ADOPTING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM NO. 2024-05 OF THE MUNICIPALITY OF BINALONAN, PANGASINAN”**

**WHEREAS**, the Sangguniang Bayan of Binalonan, Pangasinan submitted its Resolution No. 2024-122 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

1. Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Municipal Development Council of Binalonan, Pangasinan has identified items in their Supplemental Annual Investment Program No.2024-05. This was endorsed to the Sangguniang Bayan for approval on October 7, 2024 by the Municipal Development Council-Executive Committee thru Resolution No. 05-2024; and
2. The SAIP covers the Construction of a 7-storey UEP Building (Phase I) with the total investment requirement of Php 300,000,000.00, proposed to be funded from the loan proceeds from the LandBank of the Philippines.
