RESOLUTION NO. 22-2023

APPROVING RESOLUTION NO. 106-2022 OF THE SANGGUNIAN BAYAN OF LABRADOR, PANGASINAN, ENTITLED "APPROVING SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM NO. 2 FOR CY 2022 OF THE MUNICIPALITY OF LABRADOR, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Labrador, Pangasinan submitted its SB Resolution No. 106-2022 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

1. The Municipal Development Council of Labrador, Pangasinan prepared their Supplemental Annual Investment Program (SIP) No. 2 for CY 2022. This was endorsed by the Council, through MDC Resolution No. 003-S-2022 dated November 24, 2022, to the Sangguniang Bayan for approval;
2. Said Supplemental Annual Investment Program covers the granting of Collective Negotiation Agreement (CNA) Incentives to municipal officials and employees of the LGU, in the amount of ₱1,032,000.00; and

3. Funding for the Supplemental AIP is embodied in their Supplemental Budget No. 2, FY 2022, which was enacted by their Sangguniang Bayan through Appropriation Ordinance No. 02-2022, Series of 2022 dated November 28, 2022 and approved by the Municipal Mayor on December 5, 2022.


WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Labrador, Pangasinan;


