PROVINCIAL RESOLUTION NO. 220-2023

RATIFYING THE MEMORANDUM OF AGREEMENT (MOA) ENTERED INTO AND SIGNED BETWEEN THE PROVINCIAL GOVERNOR, RAMON V. GUICO III, WITH THE DEPARTMENT OF AGRARIAN REFORM (DAR) AND AGRARIAN REFORM BENEFICIARIES ORGANIZATION (ARBO) FOR THE PROVISION OF FARM MACHINERIES AND EQUIPMENT UNDER THE SUSTAINABLE AND RESILIENT AGRARIAN REFORM COMMUNITIES PROGRAM (SuRe ARC PROJECT) IN THE PROVINCE OF PANGASINAN

WHEREAS, one of the main thrusts of the provincial government is to support the smooth implementation of the national government's programs through countrywide agricultural development;

WHEREAS, the Provincial Government of Pangasinan in collaboration with the Department of Agrarian Reform (DAR) and the Agrarian Reform Beneficiaries Organization (ARBO) shall implement farm mechanization through the provision of farm machineries and equipment under the Sustainable and Resilient Agrarian Reform Communities Program (Sure ARC Project);

WHEREAS, since agriculture is considered as one of the basic industries in the Province of Pangasinan, the Program would definitely boost the agriculture sector not only to bring an increased income to the farmers but also to ensure their production of improved crop varieties and quality of plant materials;

WHEREAS, in the implementation of the Program, DAR Provincial Office shall provide funds to the Province of Pangasinan in the amount of Seven Hundred Ninety Thousand Pesos (P790,000.00) for the procurement and provision of farm machineries and equipment;
