APPROVING RESOLUTION NO. 390, S-2024 OF THE SANGGUNANG OF BAYAN OF ASINGAN, PANGASINAN, ENTITLED "APPROVING THE MUNICIPAL DEVELOPMENT COUNCIL RESOLUTION NUMBER 8 WITH THE CY 2024 SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM NUMBER 7 OF THE MUNICIPALITY OF ASINGAN, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Asingan, Pangasinan submitted its Resolution No. 390, S-2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

1. Subject resolution is in consonance with Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Local Development Council of Asingan, Pangasinan had identified items in their Supplemental Annual Investment Program (SAIP) No. 7 for CY 2024. This was endorsed to the Sangguniang Bayan for approval on November 27, 2024 by the Municipal Development Council thru Resolution No. 8, S-2024;
2. The Supplemental Annual Investment Program No. 7 with an investment requirement amounting to Php2,470,934.97 covers fund augmentation for Personal Services and Maintenance and Other Operating Expenses in the Office of the Mayor of LGU Asingan;

3. Likewise, SAIP No. 07 also covers the implementation of programs, projects and activities (Purchase of Sprayers for farmers and Concreting of FMR at Zones 2-4, Carosucan Sur) to be funded from the municipality's share from the FY 2022 Burley and Native Tobacco Excise Tax Collection. Said project is consistent with Local Budget Memorandum No. 91 dated August 29, 2024; and
4. The Sangguniang Bayan enacted Supplemental Budget No. 4 through Appropriation Ordinance No.6, Series of 2024 dated December 16, 2024 to support the full implementation of the Supplemental Annual Investment Program No. 07 of LGU Asingan.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Asingan, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Noel C. Bince and Salvador S. Perez, Jr. and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to approve Resolution No. 390, S-2024 of the Sangguniang Bayan of Asingan, Pangasinan, entitled “Approving the Supplemental Annual Investment Plan of Supplemental Budget No. 2, CY 2024”;
