### RESOLUTION NO. 226-2023

#### DECLARING THE ANNUAL BUDGET FOR CALENDAR YEAR 2023 OF ANDA, PANGASINAN INVOLVING A TOTAL APPROPRIATION OF P170,061,157.55, OPERATIVE IN ITS ENTIRETY

**WHEREAS**, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

**WHEREAS**, the Sangguniang Bayan of Anda, Pangasinan submitted its Annual Budget for Calendar Year 2023 involving total appropriations of P170,061,157.55, which was enacted on November 14, 2022 through Appropriation Ordinance No. 03, Series of 2022;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted review and study on said budget with the following findings:

1. That the grant of the Fourth Tranche salary adjustment to all municipal officials and employees shall be in accordance with the provisions of Local Budget Circular No. 149 dated January 10, 2023. The appropriation for salaries of the following employees should therefore be adjusted as follows:

2. That the projects under the 20% of the Annual National Tax Allotment for development projects (20% Development Fund) shall be subject to the provisions of DBM-DOF-DILG Joint Memorandum Circular (JMC) No. 1 dated November 4, 2020 re: Revised Guidelines on the Appropriation and Utilization of the Twenty Percent (20%) of the Annual Internal Revenue Allotment (IRA) for Development Projects;
3. That the items funded out of the Local Disaster Risk Reduction and Management Fund shall be in accordance with R.A No. 10121 known as the as the Philippine Disaster Risk Reduction and Management Act of 2010 and its IRR, and the Department of Budget and Management - National Disaster Risk Reduction and Management Council - Department of the Interior and Local Government (DILG) Joint Memorandum Circular No. 2013-1 dated March 25, 2013 re Allocation and Utilization of the Local Disaster Risk Reduction and Management Fund (LDRRMF);
4. That all procurements to be undertaken shall be subject to the provisions of R.A. No. 9184 (The Government Procurement Reform Act) and its revised Implementing Rules and Regulations;
5. That all programs, projects and activities shall be accordance with the approved Local Development Plan and the FY 2023 Annual Investment Program of the municipality formulated pursuant to DILG-NEDA-DBM-DOF Joint Memorandum Circular No. 1, Series of 2007 dated 08 March 2007;

6. That the appropriation for Other Personnel Benefits shall only be disbursed upon issuance of circular/guidelines granting the same, otherwise, the same is bereft of legal basis;
7. That the utilization of all appropriation for Capital Outlay, shall as may be applicable, be subject to the authorization of the Sanggunian on the list of projects to be implemented as ruled by the Supreme Court in the case of Hon. Gabriel Luis Quisumbing et. al vs Hon. Gwendolyn F. Garcia, et. al G. R. 1755-22, December 8, 2008; and
8. That the effect of the Final FY 2023 NTA shares of the municipality necessitate the prioritization in the implementation of items of appropriations by the LGU.

**WHEREAS**, the Sangguniang Panlalawigan after final evaluation, finds the same in order provided that the findings shall be complied with by the municipality;

**WHEREFORE**, in view of the foregoing, on motion of SP Members Napoleon C. Fontelera, Jr. and Apolonia DG. Bacay and co-sponsored by SP Members Jerome Vic O. Espino, Jeanne Jinky C. Zaplan and Arthur C. Celeste, Jr., duly seconded, it was—

**RESOLVED**, as it is hereby resolved, by the Sangguniang Panlalawigan in session assembled, to declare Operative in its Entirety the Annual Budget for Calendar Year 2023 of Anda, Pangasinan;

**RESOLVED FURTHER**, that a copy of this resolution be furnished the Office of the Sangguniang Bayan of Anda, Pangasinan, for its information and guidance.
