**APPROVING RESOLUTION NO. 2022-339 OF THE SANGGUNIAN BAYAN OF MANGALDAN, PANGASINAN, ENTITLED “APPROVING AND ADOPTING THE ANNUAL INVESTMENT PROGRAM (AIP) CY 2023 OF THE MUNICIPALITY OF MANGALDAN, PANGASINAN”**

**WHEREAS**, the Sangguniang Bayan of Mangaldan, Pangasinan submitted its SB Resolution No. 2022-339 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

1. Subject Resolution is in consonance to Section 106, 109 and 114 of the Local Government Code of 1991. The Municipal Development Council of Mangaldan, Pangasinan had identified and prioritized programs and projects in their Annual Investment Program for CY 2023. This was endorsed by the Council to the Sangguniang Bayan through MDC Resolution No. 4, Series of 2022 dated October 11, 2022;
2. The Annual Investment Program of said LGU is in accordance with the Budget Operations Manual (BOM) for Local Government Units, 2016 Edition, and in pursuance to DILG-NEDA-DBM-DOF Joint Memorandum Circular No. 1, Series of 2007 dated March 8, 2007 and

DBM-CCC-DILG JMC No. 2015-1 dated July 23, 2015 as to format and content. The AIP was prepared using the prescribed AIP Summary Form, and covers: (a) all the regular budgetary requirements for the operation of the different offices, broken down into Personal Services (PS), Maintenance and Other Operating Expenses (MOOE) and Capital Outlay, (b) priority development programs/projects of the LGU, including those funded by the 20% Development Fund, (c) Local Disaster-Risk Reduction and Management (LDRRM) programs, projects, and activities, and (d) activities in pursuance of the objectives of Gender and Development (GAD) of the LGU. Also attached to the AIP, among others, are the following: (a) Local Climate Change Adaption Plan, CY 2023, (b) Municipal Peace and Order and Public Safety Action Plan, CY 2023, (c) Local Youth Development Plan, CY 2023, (d) Municipal Tourism and Cultural Development Plan, CY 2023, (e) Indicative Annual Procurement Plan, CY 2023, (f) List of PPAs for the Local Council for the Protection of Children, CY 2023, (g) List of PPAs for Senior Citizens and Persons with Disabilities, CY 2023, (h) List of PPAs for the Prevention and Control of STI, HIV & AIDS, CY 2023, and (i) Municipal Anti-Drug (MADAC) Action Plan, CY 2023 of the LGU;

3. The AIP of Mangaldan for CY 2023 has a total investment requirement of P12,456,597,733.00. Of this, P415,538,733.00 will be financed by the LGU as embodied in their 2023 Annual Budget passed and approved by their Sangguniang Bayan through Appropriation Ordinance No. 2022-06 dated December 5, 2022. The remaining amount of P12,041,059,000.00 will be outsourced from various Government Offices/Agencies (local and national);
4. Said AIP is in accordance with Section 287 of LGC of 1991. More than 20% of the LGU's Internal Revenue Allotment/National Tax Allotment (P303,128,733.00), amounting to P61,000,000.00, is allocated for development projects.
5. The development projects proposed to be funded by the 20% Development Fund were based on the Joint DBM-DILG Memorandum Circular No. 1 dated November 4, 2020 (Revised Guidelines on the Appropriation and Utilization of the 20% of the Annual Internal Revenue Allotment for Development Projects).
6. The Disaster Risk Reduction and Management Plan, in preparation for and to mitigate the impact of disaster, to be funded by the 5% LDRRM Fund in the amount of P19,000,000.00 is in conformity to Section 21 of RA 10121;

The programs, projects and activities to be funded by the 70% of the 5% LDRRM Fund in the amount of P13,300,000.00 were based on NDRRMC – DBM – DILG JMC No. 2013-1 dated March 25, 2013 (Allocation and Utilization of the Local Disaster Risk Reduction and Management Fund). Further, the plan was already reviewed by the Provincial Local DRRM Plan Review Team and re-evaluated by the Office of the Civil Defense - Regional Office I;

7. The Gender and Development Plan and Budget (2023) of the LGU was reviewed and approved by the DILG Provincial Office, and found to be compliant in form and content with the provisions of the PCW-DILG-DBM-NEDA Joint Memorandum Circular (JMC) Nos. 2013-01 and 2016-01 (Guidelines on the Localization of the Magna Carta of Women); and
8. The LGU of Mangaldan had also identified programs, projects and activities which are responsive to Climate Change and tagged its corresponding expenditures in their AIP. This is in pursuance to DBM-CCC-DILG Joint Memorandum Circular No. 2015-01 dated July 23, 2015.

**WHEREAS**, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Mangaldan, Pangasinan;

**WHEREFORE**, in view of the foregoing, on motion of SP Members Marinor B. De Guzman and Jerry Agerico B. Rosario and co-sponsored by SP Members Jerome Vic O. Espino, Jeanne Jinky C. Zaplan and Arthur C. Celeste, Jr., duly seconded, it was—

**RESOLVED**, by the Sangguniang Panlalawigan in session assembled, to approve SB Resolution No. 2022-339 of the Sangguniang Bayan of Mangaldan, Pangasinan, entitled “Approving and Adopting the Annual Investment Program (AIP) CY 2023 of the Municipality of Mangaldan, Pangasinan”;
