DECLARING THE ANNUAL BUDGET FOR CALENDAR YEAR 2023 OF MANGALDAN, PANGASINAN INVOLVING A TOTAL APPROPRIATION OF P415,538,733.00, OPERATIVE IN ITS ENTIRETY

WHEREAS, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

WHEREAS, the Sangguniang Bayan of Mangaldan, Pangasinan submitted its Annual Budget for Calendar Year 2023 involving total appropriations of P415,538,733.00, which was enacted on December 5, 2022 through Appropriation Ordinance No. 2022-06;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted review and study on said budget with the following findings:

1. That the appropriations for the implementation of the Fourth Tranche compensation adjustments shall be subject to the provisions of Local Budget Circular (LBC) No. 149 dated January 10, 2023 re: Implementation of the Fourth Tranche of the Modified Salary Schedule for Local Government Personnel Pursuant to Republic Act (RA) No. 11466;

- 2. That the projects funded under the 20% of the Annual National Tax Allotment for development projects (20% Development Fund) shall be subject to the provisions of DBM DOF DILG Joint Memorandum Circular (JMC) No. 1 dated November 4, 2020 re "Revised Guidelines on the Appropriation and Utilization of the twenty percent (20%) of the Annual Internal Revenue Allotment for Development Projects."
- 3. That the items funded out of the Local Disaster Risk Reduction and Management Fund shall be in accordance with R.A. No. 10121 known as the Philippine Disaster Risk Reduction and Management Act of 2010 and its IRR, and the Department of Budget and Management National Disaster Risk Reduction and Management Council Department of the Interior and Local Government (DILG) Joint Memorandum Circular No. 2013-1 dated March 25, 2013 re Allocation and Utilization of the Local Disaster Risk Reduction and Management Fund (LDRRMF);
- 4. That all procurements to be undertaken shall be in accordance with the pertinent provisions of R.A. No. 9184 (The Government Procurement Reform Act.) and its revised Implementing Rules and Regulations;
- 5. That all programs, projects and activities shall be in accordance with the approved Local Development Plan and FY 2023 Annual Investment Program of the municipality formulated pursuant to DILG-NEDA-DBM-DOF Joint Memorandum Circular No. 1, Series of 2007 dated 08 March 2007;
- 6. That the utilization of all appropriations for Capital Outlay shall as may be applicable, be subject to the authorization of the Sanggunian on the list of projects to be implemented as ruled by the Supreme Court in the case of Hon. Gabriel Luis Quisumbing, et al vs. Hon. Gwendolyn F. Garcia, et al., G.R. No. 175527, December 8, 2008;
- 7. That the grant of step increment to some municipal officials and employees shall be in accordance with DBM-CSC Joint Circular No. 1, s-2012 dated September 3, 2012 and CSC-DBM Joint Circular No. 01, s-2016 dated January 27, 2016; and
- 8. That the appropriation for Other Personnel Benefits shall not be disbursed until such time that a circular authorizing the same is issued by proper authority, otherwise, the same shall be deemed bereft of legal basis.
