RESOLUTION NO. 229-2025

DECLARING ORDINANCE NO. 12, S-2024 OF THE SANGGUNIANG BAYAN OF ASINGAN, PANGASINAN, ENTITLED “AN ORDINANCE ESTABLISHING THE “KATUWANG SA DIWA AT GAWA PARA SA MASAGANANG ANI AT MATAAS NA KITA (KADIWA) NG PANGULO” IN THE MUNICIPALITY” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Asingan, Pangasinan submitted its Ordinance No. 12, Series of 2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer conducted initial review and study on said ordinance and found out that the same was enacted in accordance with Sections 16, 17 (b) (2) (i) (xi) and 447 (a) (4) (iv) (5) (ii) (iv) of R.A. No. 7160; and Department of the Interior and the Local Government Memorandum Circular No. 2024-003;

WHEREFORE, in view of the foregoing, on motion of SP Members Noel C. Bince and Salvador S. Perez, Jr. and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to declare Ordinance No. 12, Series of 2024 of the Sangguniang Bayan of Asingan, Pangasinan, entitled “An Ordinance establishing the “Katuwang Sa Diwa at Gawa para sa Masaganang Ani at Mataas na Kita (KADIWA) ng Pangulo” in the Municipality” as within the conferred powers of the Sangguniang Bayan to enact;
