RESOLUTION NO. 235-2023

DECLARING THE ANNUAL BUDGET FOR CALENDAR YEAR 2023 OF NATIVIDAD, PANGASINAN INVOLVING A TOTAL APPROPRIATION OF P142,893,111.00, OPERATIVE IN ITS ENTIRETY

WHEREAS, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

WHEREAS, the Sangguniang Bayan of Natividad, Pangasinan submitted its Annual Budget for Calendar Year 2023 involving total appropriations of P142,893,111.00, which was enacted on November 21, 2022 through Appropriation Ordinance No. 03-2022;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted review and study on said budget with the following findings:

1. That the appropriations for the implementation of the Fourth Tranche compensation adjustment shall be subject to the provisions of Local Budget Circular No. 149 dated January 10, 2023;
2. That the Productivity Enhancement Incentive (PEI) in the amount of P5,000.00 each may be granted to qualified personnel not earlier than December 15 of every year, subject to the rules and regulations provided under Budget Circular No. 2017-4 dated December 04, 2017;

3. That the grant of step increment to municipal officials and employees and elective officials shall be subject to the provisions of Civil Service Commission (CSC) and Department of Budget and Management (DBM) Joint Circular No. 1, S. 2012 and JC No. 1, S. 2016 dated September 3, 2012 and January 27, 2016, respectively;
4. That the purchase of motor vehicles shall be subject to the provisions of Budget Circular No. 2022 - 1 of the Department of Budget and Management dated February 11, 2022 re "Omnibus Guidelines On The Acquisition, Use, Rental, and Replacement of Government Motor Vehicles;
5. That the effect of Final FY 2023 National Tax Allotment (NTA) shares of the municipality necessitate the prioritization in the implementation of items of appropriations of the LGU;
6. That the appropriations for devolved functions and services in FY 2023 shall be in accordance with the provisions of Executive Order No. 138 dated June 1, 2021 and DILG - DBM Joint Memorandum Circular (JMC) No. 2021-1 dated August 11, 2021, and shall be consistent with the Devolution Transition Plan of the municipality;
7. That the items funded out of the Local Disaster Risk Reduction and Management Fund shall be in accordance with R.A. No. 10121 known as the Philippine Disaster Risk Reduction and Management Act of 2010 and its IRR, and the DBM - NDRRMC - DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013 re Allocation and Utilization of the Local Disaster Risk Reduction and Management Fund (LDRRMF);
8. That the projects funded under the 20% of the Annual National Tax Allotment for development projects (20% Development Fund) shall be subject to the provisions of DBM - DOF - DILG Joint Memorandum Circular (JMC) No. 1 dated November 4, 2020 re "Revised Guidelines on the Appropriation and Utilization of the twenty percent (20%) of the Annual Internal Revenue Allotment for Development Projects";
9. That all programs, projects and activities shall be in accordance with the approved Local Development Plan and FY 2023 Annual Investment Program of the municipality formulated pursuant to DILG - NEDA - DBM - DOF Joint Memorandum Circular No. 1, Series of 2007 dated 08 March 2007; and
