## RESOLUTION NO. 236-2025

### DECLARING SUPPLEMENTAL BUDGET NO. 4 FOR CALENDAR YEAR 2024 OF THE CITY OF SAN CARLOS, PANGASINAN, INVOLVING A TOTAL APPROPRIATION OF P7,862,685.15, OPERATIVE IN ITS ENTIRETY

**WHEREAS**, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

**WHEREAS**, the Sangguniang Panlungsod of San Carlos, Pangasinan submitted its Supplemental Budget No. 04-24 for Calendar Year 2024 involving total appropriations of Php7,862,685.15 which was enacted on September 2, 2024 through Appropriation Ordinance No. 24-15;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted review and study on said budget with the following findings:

1. That the funding source for the subject Supplemental Budget were determined in accordance with Section 321 of R.A. No. 7160 and Article 417(a) of its IRR, as amended by Administrative Order No. 47 dated April 12, 1993;
2. That the reversion of savings shall be in accordance with the provisions of Section 336 of R.A. 7160 (Use of Appropriated Funds and Savings);

3. That all programs, projects and activities to be implemented are in accordance with the approved CY 2024 Annual Investment Program of the Municipality and the supplements thereto formulated pursuant to DILG-NEDA-DBM-DOF JMC No. 1, Series of 2007 dated March 8, 2007;
4. That all procurements to be undertaken shall be subject to the pertinent provisions of R.A. 9184 and its Implementing, Rules and Regulations;
5. That the procurement of transportation equipment shall be subject to the provisions of Budget Circular No. 2022-1 of the Department of Budget and Management, dated February 11, 2022 re: "Omnibus Guidelines on the Acquisition, Use, Rental, and Replacement of Government Motor Vehicles" and BC No. 2022-1A dated March 1, 2023 (Supplemental Guidelines on the Acquisition, Use, Rental and Replacement of Government Motor Vehicles); and
6. That the items funded out of the Local Disaster Risk Reduction and Management Fund shall be in accordance with R.A. No. 10121, known as the Philippine Disaster Risk Reduction and Management Act of 2010 and its IRR, and the DBM-NDRRM-DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013 re: Allocation and Utilization of the Local Disaster Risk Reduction and Management Fund (LDRRMF), and that 30% shall be set aside as Quick Response Fund.

**WHEREAS**, the Sangguniang Panlalawigan after final evaluation, finds the same in order provided that the findings shall be complied with by the City;

**WHEREFORE**, in view of the foregoing, on motion of SP Members Shiela Marie F. Baniqued and Vici M. Ventanilla and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—

**RESOLVED**, as it is hereby resolved, by the Sangguniang Panlalawigan in session assembled, to declare Operative in its Entirety the Supplemental Budget No. 04-24 for Calendar Year 2024 of San Carlos City, Pangasinan;

**RESOLVED FURTHER**, that a copy of this resolution be furnished the Office of the Sangguniang Panlungsod of San Carlos, Pangasinan, for its information and guidance.
