#### **RESOLUTION NO. 240-2025**

DECLARING MUNICIPAL ORDINANCE NO. 10-2024 OF THE SANGGUNIANG BAYAN OF ANDA, PANGASINAN, ENTITLED "AN ORDINANCE APPROVING AND ADOPTING THE INTEGRATED ZONING ORDINANCE FOR THE MUNICIPALITY OF ANDA, PANGASINAN AND PROVIDING THE ADMINISTRATION, ENFORCEMENT AND FOR THE REPEAL OF ALL ORDINANCES IN CONFLICT THEREWITH" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

**WHEREAS,** the Sangguniang Bayan of Anda, Pangasinan submitted its Ordinance No. 10, S-2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer, and the Provincial Land Use Committee (PLUC) have conducted initial review and study on said ordinance and found out that the same was enacted pursuant to Section 447 (a) (2) (ix) of RA 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Zoning Ordinance of Anda, Pangasinan had undergone the technical review by the Provincial Land Use Committee (PLUC) of the Province of Pangasinan pursuant to Section 2 (b) of Executive Order No. 72, S-1993;

**WHEREAS**, the PLUC found the Zoning Ordinance of Anda, Pangasinan to be in conformity with the existing Land Use Planning Guidelines, Laws and Regulations and other development plans of the Province;
