PROVINCIAL RESOLUTION NO. 243-2023

INVITING THE PROVINCIAL AGRICULTURIST, MRS. DALISAY A. MOYA, AND DR. ANNIE Q. BARES, REGIONAL EXECUTIVE DIRECTOR, DEPARTMENT OF AGRICULTURE, REGIONAL FIELD OFFICE 1, TO A QUESTION HOUR OF THE SANGGUNIAN PANLALAWIGAN DURING ITS MARCH 13, 2023 REGULAR (PHYSICAL) SESSION TO RENDER A REPORT ON THE STATUS OF AGRICULTURE AND AGRICULTURAL PROGRAMS INCLUDING NATIONAL GOVERNMENT-INITIATED PROGRAMS IN THE PROVINCE OF PANGASINAN

WHEREAS, Republic Act 7160, otherwise known as the Local Government Code of 1991, mandates local government units to effect good governance for food security and make food available, affordable and accessible in their respective jurisdiction;

WHEREAS, Pangasinan is an agricultural Province and most people especially farmers and fisherfolks are dependent on their livelihood of fishing, planting and harvesting essential products;

WHEREAS, one of the priority programs of the present administration is increasing the productivity output and profitability of its farmers and fisherfolks in support to the food sufficiency program of the national government;

WHEREAS, the Provincial Agriculture Office is the proper authority that can ensure maximum assistance and access to resources in the production, processing and marketing of agricultural, aquacultural and marine products of farmers and fisherfolks;

WHEREAS, likewise, the Question Hour set for March 13, 2023 is an avenue for the Sangguniang Panlalawigan and all and sundry to be ventilated on the policies being undertaken by the Provincial Agriculture Office, in collaboration with the Department of Agriculture, towards the implementation of agricultural programs, projects and activities in the Province;

WHEREAS, the Sangguniang Panlalawigan of Pangasinan is disturbed by the fact whether or not the Province of Pangasinan is on the right track of being at par with other provinces in terms of agricultural development;
