APPROVING SB RESOLUTION NO. 62, S-2024 OF THE SANGGUNANG BAYAN OF BANI, PANGASINAN, ENTITLED “APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM NO. 5 FY 2024 OF THE MUNICIPALITY OF BANI, PANGASINAN AMOUNTING TO SIX MILLION, EIGHT HUNDRED THOUSAND, FIVE HUNDRED PESOS (PHP6,800,500.00) FUNDED BY THE REVERTED SAVINGS OF THE MUNICIPAL DEVELOPMENT FUND FY 2024 AND REPROGRAMMED SEVENTY PERCENT LDRRMF 2024”

WHEREAS, the Sangguniang Bayan of Bani, Pangasinan submitted its Resolution No. 62, S-2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

1. In consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991, the Local Development Council of Bani, Pangasinan had identified items in their Supplemental Investment Program (SIP) No. 5 CY 2024. This was endorsed to the Sangguniang Bayan on November 12, 2024 through MDC Resolution No. 2024-11;

2. The SIP No. 5 covers the implementation of development projects and disaster risk reduction and management projects of the LGU with a total funding requirement of Php6,800,500.00;

The identified programs/projects proposed to be funded from the 20% development fund are based on DBM-DOF-DILG Joint Memorandum Circular No.1 dated November 4, 2020 (Revised Guidelines on the Appropriation and Utilization of the 20% of the Annual Internal Revenue Allotment for Development Projects);

The reprogrammed disaster risk reduction and management project, which has emanated from the Local Disaster Risk Reduction & Management Council and approved through MDRRMC Resolution No. 06, Series of 2024, is based on the NDRRMC-DBM and DILG Memo Circular No. 2013-1 dated March 25, 2013 (Allocation and Utilization of Local Disaster Risk Reduction and Management Fund);

3. Funding support for the implementation of the said SIP will be sourced out from the realigned/reverted CY2024 municipal development fund amounting to Php5,800,500.00, which is also the subject of SB Resolution No. 61-S.2024, under review, and the reprogrammed 70% LDRRM Fund FY 2024 in the amount of Php1,000,000.00.;
4. Funding for the full implementation of the same is embodied in the municipality's Supplemental Budget No. 04 CY 2024, which was approved and enacted by their Sangguniang Bayan through Appropriation Ordinance No. 05-S.2024 on December 9, 2024 and approved by the Municipal Mayor on December 20, 2024.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Bani, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Napoleon C. Fontelera, Jr. and Apolonia DG. Bacay and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to approve SB Resolution No. 62, S-2024 of the Sangguniang Bayan of Bani, Pangasinan, entitled “Approving the Supplemental Investment Program No. 5 FY 2024 of the Municipality of Bani, Pangasinan amounting to Six Million, Eight Hundred Thousand, Five Hundred Pesos (Php6,800,500.00) funded by the reverted savings of the Municipal Development Fund FY 2024 and reprogrammed seventy percent LDRRMF 2024”;
