S-2024 OF THE APPROVING RESOLUTION NO. 67, SANGGUNIANG BAYAN OF BANI, PANGASINAN, ENTITLED "APPROVING THE REVISED ANNUAL INVESTMENT PROGRAM FY 2024 (REVISED AIP 2024) AMOUNTING TO TWO HUNDRED **NINETY-NINE** FORTY-SIX MILLION, **FOUR** HUNDRED THOUSAND, NINE HUNDRED FORTY-FIVE PESOS AND 65/100 **FUNDED** THE MUNICIPAL (PHP246,499,945.65) BY DEVELOPMENT FUND (MDF), GENERAL FUND (GF) BOTH FY 2024 AND LDRRMF SPECIAL TRUST FUND FY 2023 OF THE MUNICIPALITY OF BANI, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Bani, Pangasinan submitted its Resolution No. 67, S-2024 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

1. Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Local Development Council of Bani, Pangasinan had identified items in their Revised Annual Investment Program for CY 2024. This was endorsed to the Sangguniang Bayan on November 14, 2024 through MDC Executive Committee Resolution No. 2024-01;

2. The AIP of LGU Bani was revised to integrate the proposed disaster risk reduction and management program (to augment LDRRM Quick Response Fund 2024) to be funded from the unexpended balances of the LGU's LDRRM Fund CY 2023 amounting to PhP3,311,290.14, which emanated from the MDRRM Council through Resolution 07, Series of 2024 dated October 26, 2024 and integrated in their Revised MDRRM Fund Investment Plan for CY 2024. This is in pursuance to Section 6.5 of the NDRRMC-DBM-DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013, which states "The unexpended balances of the LDRRMF may be released and utilized for new expenditure items upon submission of a revised AIP as approved by the local sanggunian and Local Chief Executive (LCE) upon recommendation of the LDRRMC in accordance with the approved LDRRMP".

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Bani, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Napoleon C. Fontelera, Jr. and Apolonia DG. Bacay and co-sponsored by SP Members Carolyn D. Sison, Joyce D. Fernandez and Raul R. Sabangan, duly seconded, it was—

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to approve Resolution No. 67, S-2024 of the Sangguniang Bayan of Bani, Pangasinan, entitled "Approving the Revised Annual Investment Program FY 2024 (Revised AIP 2024) amounting to Two Hundred Forty-Six Million, Four Hundred Ninety-Nine Thousand, Nine Hundred Forty-Five Pesos and 65/100 (Php246,499,945.65) funded by the Municipal Development Fund (MDF), General Fund (GF) both FY 2024 and LDRRMF Special Trust Fund FY 2023 of the Municipality of Bani, Pangasinan";

RESOLVED FURTHER, that a copy of this resolution be furnished the Office of the Sangguniang Bayan of Bani, Pangasinan, for its information and guidance.
