**RESOLUTION NO. 249-2023**

**APPROVING RESOLUTION NO. 268, S-2022 OF THE SANGGUNANG BAYAN OF BINMALEY, PANGASINAN, ENTITLED "APPROVING THE 2023 ANNUAL INVESTMENT PROGRAM (AIP) OF THE MUNICIPAL GOVERNMENT OF BINMALEY, PANGASINAN"**

**WHEREAS**, the Sangguniang Bayan of Binmaley, Pangasinan submitted its SB Resolution No. 268, Series of 2022 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

1. Subject Resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code of 1991. The Municipal Development Council of Binmaley, Pangasinan had identified and prioritized programs and projects in their Annual Investment Program for CY 2023. This was endorsed by the Council to the Sangguniang Bayan through MDC Resolution No. 3, Series of 2022 dated October 6, 2022;
2. The Annual Investment Program of the municipality is in accordance with the Budget Operations Manual (BOM) for Local Government Units, 2016 Edition, and in pursuance to DILG-NEDA-DBM-DOF Joint Memorandum Circular No. 1, Series of 2007 dated March 8, 2007 and DBM-CCC-DILG JMC No. 2015-1 dated July 23, 2015 as to

format and content. The AIP of Binmaley was prepared using the prescribed AIP Summary Form, and covers: (a) all the regular budgetary requirements for the operation of the different offices broken down into Personal Services (PS), Maintenance and Other Operating Expenses (MOOE) and Capital Outlay, (b) priority development programs/projects of the LGU, including those funded by the 20% Development Fund, (c) Disaster-Risk Reduction (DRR) programs, projects, and activities, and (d) activities in pursuance of the objectives of Gender and Development (GAD) of the LGU as indicated in the DILG-endorsed GAD Plan and Budget. Also attached to the AIP are the following: (a) Local Climate Change Action Plan, (b) Peace and Order Plan (c) Municipal Youth Development Plan, (d) Local Nutrition Action Plan 2023-2024, (e) Annual Cultural Development Plan, (e) Annual Procurement Plan, (f) List of PPAs for the Local Council for the Protection of Children, (g) List of PPAs for Senior Citizens and Persons with Disabilities, (h) List of PPAs to Combat Acquired Immune Deficiency Syndrome, and (i) List of PPAs to Address the Problem of Illegal Drugs of the LGU;

3. The proposed AIP of Binmaley for CY 2023 has a total investment requirement of P301,645,095.56. This will be financed by the LGU (P291,120,895.56 from the General Fund and P10,524,200.00 from the operation of Economic Enterprise) as embodied in their proposed Annual Budget for CY 2023 which was enacted by their Sangguniang Bayan through Appropriation Ordinance No. 3, Series of 2022 dated December 13, 2022;
4. This AIP is in accordance with Section 287 of LGC of 1991. Twenty percent (20%) of the LGU's IRA/NTA (P262,530,634.00), amounting to P52,506,126.80, is allocated for development projects;
5. The development projects proposed to be funded by the 20% Development Fund were based on the Joint DBM-DOF-DILG Memorandum Circular No. 1 dated November 4, 2020 (Revised Guidelines on the Appropriation and Utilization of the 20% of the Annual Internal Revenue Allotment for Development Projects);
6. Not less than 5% (P14,556,044.78) of the estimated revenue from regular sources were set aside as the LDRRMF in accordance with Section 21 of RA 10121 (Philippine DRRM Act of 2010). The programs, projects and activities (PPAs) proposed to be funded from the 70% of the 5% of the Local Disaster Risk Reduction and

Management Fund are based on Joint Memorandum Circular No. 2013-1 of the NDRRMC, DBM & DILG dated March 25, 2013 (Allocation and Utilization of the Local Disaster Risk Reduction and Management Fund). It is, however, recommended that the LDRRM Plan of the LGU be forwarded to the Office of Civil Defense – Regional Office I for their review/evaluation as per provisions of DBM Local Budget Memorandum No. 77 dated May 15, 2018, particularly Item 2.2.12 (...Annual Investment Program, supported by OCD-reviewed LDRRM Plan, etc.) and DBM Local Budget Memorandum No. 85 dated June 15, 2022, particularly Item 2.2.17 (...AIP, supported by LDRRM Plan as reviewed by the appropriate reviewing authority...);

7. The LGU of Binmaley had also identified programs, projects and activities which are responsive to Climate Change and tagged its corresponding expenditures in their AIP. This is in pursuance to DBM-CCC-DILG Joint Memorandum Circular No. 2015-01 dated July 23, 2015; and
8. The Gender and Development Plan and Budget for CY 2023 of the LGU was reviewed and approved by the DILG Provincial Office, and found to be compliant in form and content with the provisions of the PCW-DILG-DBM-NEDA Joint Memorandum Circular (JMC) Nos. 2013-01 and 2016-01 (Guidelines on the Localization of the Magna Carta of Women).

**WHEREAS**, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Binmaley, Pangasinan;

**WHEREFORE**, in view of the foregoing, on motion of SP SP Members Philip Theodore E. Cruz and Haidee S. Pacheco and co-sponsored by SP Members Jerome Vic O. Espino, Jeanne Jinky C. Zaplan and Arthur C. Celeste, Jr., duly seconded, it was—

**RESOLVED**, by the Sangguniang Panlalawigan in session assembled, to approve SB Resolution No. 268, Series of 2022 of the Sangguniang Bayan of Binmaley, Pangasinan, entitled “Approving the 2023 Annual Investment Program (AIP) of the Municipal Government of Binmaley, Pangasinan”;


