RESOLUTION NO. 25-2023

DECLARING THE SUPPLEMENTAL BUDGET NO. 3 FOR CALENDAR YEAR 2022 OF LINGAYEN, PANGASINAN INVOLVING A TOTAL APPROPRIATION OF P13,115,400.00 OPERATIVE IN ITS ENTIRETY

WHEREAS, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

WHEREAS, the Sangguniang Bayan of Lingayen, Pangasinan submitted its Supplemental Budget No. 3 for Calendar Year 2022 involving total appropriations of P13,115,400.00, which was enacted on December 07, 2022 through Appropriation Ordinance No. 04, Series of 2022;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted review and study on said budget with the following findings:

1. That the appropriation for Collective Negotiation Agreement (CNA) Incentive for FY 2022 to all municipal officials & employees shall be subject to the provisions of Budget Circular No. 2022-3 of the Department of Budget & Management dated October 19, 2022;
2. That the reversion of savings from Personal Services and Maintenance & Other Operating Expenses shall be in accordance with the provisions of Section 336 of RA 7160 (Use of Appropriated Funds and Savings);

3. That all programs, projects and activities shall be in accordance with the approved LDP and the Fiscal Year 2022 Supplemental Investment Program of the municipality formulated pursuant to DILG-NEDA-DBM-DOF Joint Memorandum Circular No. 1, Series of 2007 dated 08 March 2007;
4. That all procurements to be undertaken shall be subject to the pertinent provisions of R.A. No. 9184 (The Government Procurement Reform Act) and its Revised Implementing Rules and Regulations; and
5. That the purchase of motor vehicle shall be subject to the provisions of Budget Circular No. 2022-1 dated February 11, 2022 re "Omnibus Guidelines on the Acquisition, Use, Rental and Replacement of Government Motor Vehicles".


WHEREAS, the Sangguniang Panlalawigan after final evaluation, finds the same in order provided that the findings shall be complied with by the municipality;

WHEREFORE, in view of the foregoing, on motion of SP Members Philip Theodore E. Cruz and Haidee S. Pacheco and co-sponsored by SP Members Jerome Vic O. Espino, Jeanne Jinky C. Zaplan and Arthur C. Celeste, Jr., duly seconded, it was—


RESOLVED, as it is hereby resolved, by the Sangguniang Panlalawigan in session assembled, to declare Operative in its Entirety the Supplemental Budget No. 3 for Calendar Year 2022 of Lingayen, Pangasinan;
